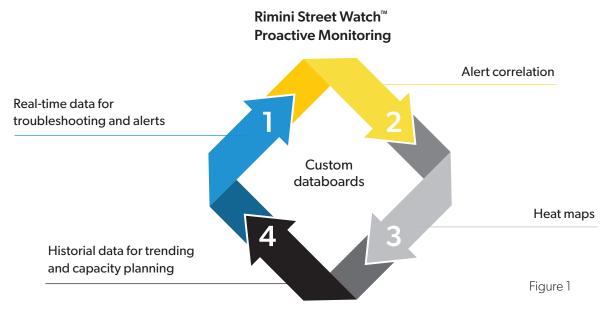
## **Business challenge**

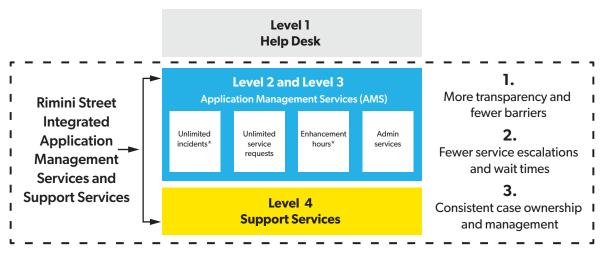
